POLICY FOR PROPERTY OWNERS WISHING TO REPLACE SIDEWALKS

THE PURPOSE of this Sidewalk Replacement Policy for DeWitt (Policy) is to provide a uniform set of guidelines and practices for property owners who wish to replace a sidewalk in front of their property. In general, this policy encourages the voluntary contributions of property owners to replace broken, heaved, deteriorated, or unsafe sidewalks adjacent to their property.

RULES:

SIDEWALK STRIP is the area from the edge of the street pavement to the front property line.

PRIOR PERMISSION FROM THE TOWN must be obtained by property owners wishing to replace a sidewalk.

PROPERTY OWNERS REPLACING SIDEWALKS ON TOWN PROPERTY are considered volunteers. The sidewalks they replace are considered donations to the Town.

APPLICATIONS TO REPLACE A SIDEWALK are available at the Highway Department office, or may be obtained via mail or facsimile by contacting the Highway Department. (315-437-8331)

REMOVAL OF OLD SIDEWALK may be performed by the Town of DeWitt Highway Department at no cost to the property owner. Please give 2 weeks notice.

COMPLETION OF THE SIDEWALK REPLACEMENT by the owner shall be no longer than 60 days after removal of the old sidewalk.

CONTRACTORS HIRED BY PROPERTY OWNERS to replace sidewalks must submit a Certificate of Insurance naming the Town as additional insured before they begin work.

SIDEWALKS SHALL BE CONSTRUCTED in accordance with the Sidewalk Construction Standards of the Town of DeWitt (see below)

CONTACT UFPO (Underground Facilities Protection Organization) **BEFORE** starting sidewalk demolition, at 1-800-962-7962. They will identify any underground utilities. UFPO requires notification at least 3 days prior to construction or demolition

EFFECTIVE DATE of this policy is March 8, 1999. (Revised June 29, 2004)



1. ALL WORK SHALL BE IN ACCORDANCE WITH THE LATEST EDITION OF "NEW YORK STATE DEPARTMENT OF TRANSPORTATION STANDARD SPECIFICATIONS CONSTRUCTION AND MATERIALS".
2. CONCRETE FOR SIDEWALK SHALL BE 4000 PSI CLASS 'A' AIR ENTRAINED.
3. CONSTRUCTION JOINTS FOR SIDEWALKS SHALL BE PLACED EVERY 5'. FULL DEPTH EXPANSION JOINTS SHALL BE PLACED EVERY 25'.
4. BROOM FINISH ALL CONCRETE SURFACES.
5. ALL DISTURBED SURFACES SHALL BE RESTORED TO ORIGINAL CONDITION.
